The Lewis & Clark Conference Administrator's meeting was held February 17, 2016 at 4:30 p.m. at Geno's in Wayne. Motion was made by Winnebago to approve the agenda for the February 17, 2016 meeting, seconded by Randolph. Voting: 17/0.

Minutes from the December 2, 2015 meeting were approved with a motion made by LCC and seconded by Plainview. Voting: 17/0.

Financial report as of February 15, 2016 submitted by Dan Fehringer was approved with a motion by Wausa and seconded by Randolph.. The Treasurer's report shows a balance of \$61,625.65. Voting: 17/0.

Noelle Petersen, music director from Homer was present to answer questions in regards to the previous proposal presented at the December 2<sup>nd</sup> meeting in regards to instrumental music. The 2016-2017 calendar will be setup and brought to the April meeting for approval.

It was discussed to move the principal award due date to the same due date as the superintendent's award. A proposal will be brought to the April meeting.

Basketball director, Bob Hayes, reported the tournament went well even though many games had to be moved due to the weather. Bob also reported that we are falling behind in official pay compared to other conferences. We need to look at what we are paying officials and consider raising their pay.

Wrestling director, Randy Kliment, reported that the tournament went well and complimented Plainview of dong a good job. He reported that the referees have already been hired for next year. He is going to check on the continued use of clocks we currently use from non conference schools.

Mark Bejot, Wakefield, reported the speech contest went well.

Corey Uldrich, Hartington, reported that they will be using a two starter system for the conference track meet. The throws will start at 9:30am and the rest of the events will start at 10:00am.

Conference Golf meet will start time at10:00am.
