VI. Action Items:

- A. Finals of the conference volleyball tournament held at a neutral site (WSC, NE CC, or Hartington CC). Rationale: In the past, when conference basketball finals were hosted at LCC if LCC was in the finals, the games were moved to a neutral site.

In volleyball, the finals rotate between LCC, Ponca, and Randolph. If the host school is in the finals, it should be moved, as basketball had been done, so the host team does not have a home-court advantage. Creating a designated neutral site for the finals would eliminate last-second moving of the finals in the event it is agreed upon that no team should have a home-court advantage in the finals.

- B. All-Star game for graduated seniors. Lewis and Clark Divisions. Rationale: An All-Star game would provide an opportunity for graduated seniors to one more game. It would also give the Lewis & Clark conference a chance to showcase ourselves and the tremendous talented student-athletes in our conference.
- C. Not charge schools for an entry fee for the Conference Cross Country Meet. Rationale: Our conference does not charge a fee for schools to enter our other Conference Tournaments.
- D. Pay the conference treasurer \$500.00. Rationale: The treasurer takes care of all the check writing, receipts, balancing the checkbook, and preparing the statements. The treasurer will also have to travel to the Wayne Bank to do the banking.
